



## **Vacant Land: Empowering Stakeholders**

Many urban areas throughout Louisiana have experienced shrinking or changing populations, thus leaving a large number of vacant lots and properties. These unattended lots and properties bring a variety of challenges to public safety, property values and quality of life for surrounding residents. While local governments have addressed these issues, it becomes a burden on governments to sustain these properties. 
